### **BOARD OF TRUSTEES MONTHLY MEETING**

Chairperson Kloeckner called the meeting to order. Craig, Kloeckner, Wray, & Director Painter were present.

Future board member, Jim Thrane, was present as a guest.

The Consent Agenda was reviewed. Wray moved to accept the Consent Agenda as presented. Kloeckner seconded the motion. All in favor.

No correspondence.

Director Painter reported that the Children's Library is experiencing more usage. The new outside light poles are up and working nicely. The neighbors have expressed their appreciation of the improvements.

# Committees & Reports:

No Friends of the Library report. Tea is October 14.

Glenwood Library Foundation meeting was attended by Craig. They requested that we provide them with some projects that we need done that needs funding. Craig also expressed her desire not to be the Foundation's board liaison. Kloeckner volunteered to take her place.

#### Old Business:

The board agreed to send Painter to the ILA Conference October 18 thru 20 with budget of \$500. Craig made the motion with a second by Kloeckner. All in favor.
